Please send in an updated vaccine record for your student as soon as possible for next year. This is required per Ohio Law.

Vaccination Requirements for 2020-2021 school year:

- all incoming 9-11th graders are required to have 1 MCV4 vaccine
- all incoming 12th graders are required to have 2 doses of MCV4 vaccine. *only need 1 if first dose was given on or after the 16th birthday*







The Charles School at Ohio Dominican University - Response to George Floyd's Murder:

We, the leadership and staff at The Charles School at Ohio Dominican University, a member of The Graham Family of Schools, are shocked and saddened by the senseless and tragic murder of George Floyd. His death, like that of Breonna Taylor and Ahmaud Arbery, spotlights the urgent need for change in our country. We are committed to being a part of that change. We have been inspired by the peaceful protests, the chants for change, and those in positions of power who have joined these movements in solidarity. We see how the justice system and police reform all too often stands opposed to our black students, families, and friends to being treated fairly and equitably. Summer Meal Information

Dear Parent(s)/Guardian(s),

All children ages 1 through 18 are eligible to receive free meals during the summer months at participating program sites. Individuals age 19 through 21 who have been identified as having mental or physical disabilities and are following Individualized Education Programs (IEP's) through their current enrollment in educational programs are also eligible for free summer meals. Important Information about Your Child's School Meals

If you have a child in kindergarten through twelfth grade in your household who was receiving free or reduced-price meals while in school, your child is eligible for the Pandemic Electronic Benefit Transfer (P-EBT) program to receive Supplemental Nutrition Assistance Program (SNAP) benefits as a result of the school closure.

What are the benefits the child will receive?

The amount of benefits is \$5.70 per child for each school day the child was eligible for free or reduced-price meals between March 17, 2020 through May 29, 2020.

Do I have to accept the card and use it?

- » No, your participation in the program is voluntary.
- » If you choose not to participate, please dispose of your card by cutting through the magnetic stripe on the card and discard the card in a secure manner.
- » If you do not want the card, you will not be able to redeem the food benefits, nor can you transfer the card to someone else

How can I use these benefits?

These benefits can be used to buy food items at grocery stores/retailers that accept the Ohio Direction Card (also referred to as an EBT card).

If the child is a current SNAP recipient:

- » By the end of May, the P-EBT benefits may be added to the account on which the child is active.
- » If the child was unable to be matched to his or her active SNAP account, you will be sent a P-EBT card in the child's name.

If the child is not a current SNAP recipient:

» By mid-June you should receive a preloaded P-EBT card in the mail. The card will be in the child's name, not the parent or guardian's name. Instructions on how to activate the card will be included.

Información importante sobre las Comidas Escolares de su Hijo

Si tiene un hijo de jardín de infantes a duodécimo grado en su hogar que estaba recibiendo comidas gratis o de precio reducido mientras estaba en la escuela, su hijo es elegible para el programa Pandemic Electronic Benefit Transfer (P-EBT) para recibir los beneficios del Programa de Asistencia Nutricional Suplementaria (SNAP) como resultado del cierre de la escuela.

¿Cuáles son los beneficios que recibirá el niño?

La cantidad de beneficios es de \$ 5.70 por niño por cada día escolar que el niño era elegible para recibir comidas gratis o a precio reducido entre el 17 de marzo, 2020 hasta el 29 de mayo de 2020.

¿Tengo que aceptar y usar la tarjeta?

- » No, su participación en el programa es voluntaria.
- » Si decide no participar, deseche su tarjeta cortando la banda magnética de la tarjeta y deséchela de manera segura.
- » Si no desea la tarjeta, no podrá canjear los beneficios de alimentos ni podrá transferir la tarjeta a otra persona.

¿Cómo puedo usar estos beneficios?

Estos beneficios se pueden usar para comprar alimentos en colmados / minoristas que aceptan la Tarjeta de Dirección de Ohio (también conocida como tarjeta EBT).

Si el niño es un usuario actual de SNAP:

- » Para fines de mayo, los beneficios de P-EBT pueden agregarse a la cuenta de SNAP en la que el niño está activo.
- » Si el niño no pudo ser pareado con su cuenta activa de SNAP, se le enviará una tarjeta P-EBT a nombre del niño.

Si el niño no es un usuario actual de SNAP:

» A mediados de junio usted debe recibir por correo una tarjeta precargada de P-EBT. La tarjeta estará a nombre del niño, no del padre o tutor. Se incluirán instrucciones sobre cómo activar la tarjeta.

RESIDENCY VERIFICATION NOTIFICATION

Per House Bill 21 community schools are now required to perform a monthly review of student files and randomly select families for residency verification. Please be sure to contact the school immediately in case of an address change. Proof of residency must be submitted within two weeks of an address change. If evidence is not provided, requests for additional documentation or a home visit may occur.
